Rental Rates: \$100 plus \$11 per acre.

Payment shall be due upon the return of the equipment.

Cleaning Fee: Lessee is responsible for returning the equipment in

good condition. Seed boxes and tubes must be cleaned and emptied, and fittings must be greased after each use. A cleaning fee of \$150 will be charged if not returned in clean condition. The Carroll County Conservation District reserves the right to refuse rental for any reason. **NO fertilizer** is allowed in the machine.

Required Attachments: A picture of the acreage meter must be taken **before AND after use**. Email photos to contact@carrollccd.org.

Transportation: Towing is allowed if within 40 miles of Center Tuftonboro Storage location at a speed not to exceed 35 mph with ¾ ton or vehicle equipped with double tongue hitch. Lessee is responsible for any damage to their own vehicle or the implement itself during transport. Above rates do not include the cost of transportation or the fee to load. The lessee is responsible for arranging transportation of the seed drill to and from the Center Tuftonboro storage location.

Additional Terms & Liability: The above-named Lessor hereby leases to the above-named Lessee the equipment listed herein ("Equipment") for the term and with the rental payments set out above. Rental payments shall be made to the Lessor at PO Box 533, Conway, NH 03818. Lessee will pay the cost of transporting the Equipment from Lessor's place of business and returning it thereto. Such transportation shall take place during the term hereof. Lessee shall indemnify Lessor against all loss or damage to the Equipment while it is out of the Lessor's possession. Damage to the Equipment, other than a total loss, shall not abate or excuse the making of prescribed rental payments. The Carroll County Conservation District reserves the right to refuse rentals. Lessee agrees to use and care for the Equipment in a careful and prudent manner, to pay all operation and maintenance expenses while the Equipment is out of the possession of the Lessor, and to make, at his/her expense, any and all repairs. The Equipment shall be returned to Lessor in as good condition as received, reasonable wear and tear excepted. If, upon its return to Lessor, the Equipment is not in such good condition, Lessor may repair it and Lessee will pay the cost of any such repairs at Lessor's regular shop rates. Lessee assumes all risk and liability for and shall hold Lessor and its assigns harmless from all damages for injuries or death to persons and property arising out of the use, possession or transportation of the Equipment. **Lessee, at his/her own expense will carry insurance with minimum general liability limits in the amount of \$300,000 per occurrence for bodily injury and/or property damage.** Neither Lessor, its assigns, the wholesale distributor, nor the Manufacturer shall be liable for any incidental or consequential damages which may result from any failure or use of the Equipment. **The Lessee must provide a Certificate of Insurance that displays these terms and the Certificate must list Carroll County Conservation District as Additional Insured.**
